she is my sweetheart, don't you agree? I think Mr. Gopalsamy will agree with me.

SHRI V. GOPALSAMY: I support you.

SHRI S. K. T. RAMACHAN-DRAN: Let us come to business, Madam. At least, Mr. Gopalsamy likes and loves my wife. Madam, let us come to the point. This is a very serious matter. When we wart to convey some very important message to somebody on the other side of the phone and wher we are in the middle of the talk, suddently there will be a cut. Then, for half an hour or one hour you try the number again, but you don't get it.

Madam, the regular irregularity in the functioning of the telecom system reached its culmination during the recent strike period. Whenever you dialled a number most of you would have heard is—there was a voice coming across the lire, "This line is very busy, please dial after some time." Then you wait for some time and dial again only to hear the same voice again, "This line is very busy, please dial after some time." Madam, we can't understand whether it was manipulated or whether the line was really very busy. Madam, it was not only during the strike period but even otherwise also the teleocom system has been regularly irregular.

Madam, since the telecom system is the nerve centre of our whole communication system, if it does not respond to the call of the people, there is no use of the system. Their mission itself is defeated and so the Ministry should take serious steps to correct the system ana see that it is put to the best possible use. Thank you very much, Madam.

Discrimination Against the workers of paradeep, New Mangalore and Tuticorin ports

SHRI PARVAT KUMAR SAMA-NTARAY(Orissa): Madam Denuty Chairman, I am drawing the attention of this House to a number of Acts enacted by this Parliament mostly for the workers, only to be forgotten in the midway when question comes of giving the privileges, benefits under the law I am particularly mentioning about the condition and plight of the cargohandling workers of the Paradeep Port, the New Mangalore Port and tne Tuticorin Por' and the Haldia Dock Complex

Madam, we have got ten major ports in the country These three Ports have come under the purview of the dock workers system For the last ten years though the law is very clear for extending the wage benefits and privileges mentioned in the Indian Dock Labour (Regulation and Employment) Act and the federation representing the dock workers, had settlements with the Government of India in the years 1980,1984 and recently in the year 1988, there is no result It is causing concern These workers around 8,000 in total, are getting less payment, and they are deprived of even getting regular payment as given to other cargo-nandlir.g workers of other major ports.

I would like to submit here that the dock workers in other major ports are not only being extended the facility of these wages but also they have been given the privilege of medical reimbursement facilities, leave with wage children education allowance Gratuity paid-holidays and other privileges But these workers are not availing all those. Even the Port Trust Board has passed a resolution extending the benefits to the Cargo-handling workers. The Government sitting in Delhi is sitting over the decision. This has happened very recently. The Paradeep Port Trust Board decided to extend the minimum wage guaranted for days for

these cargo workers. The Government of India is yet to clear it. I have information that the Government of India is still making queries. I am afraid it may lead to strike. We are already, facing price rise. Once the Dock workers go on strike, the prices will soar further in the country.

I demand for their early regulari-sation.

Non-implementation of the award of National industrial Tribunal on the Pay Scales of Employees of Rural Banks.

SHRI N. E. BALARAM (Kerala): I would like to draw the attention of the Government to some of the questions raised by the Regional Rural Bank employees. Regional Rural Bank employees have been agitating over years on the question of parity in the scales if pay o. the employees of sponsored banks, comparable posts. I think it is their legitimate demand. But so far neither the sponsoreG banks ror the Government have taken note of this agitation or found out any solution to the problem raised by the employees. As a result those bank employees have already decided to go on strike. Besides they had approached the Supreme Court also to find a solution At that stage or the advice giver by the Supreme Court, the Government has already constituted under the provisions of Industrial Disputes Act, National Industrial Tribunal to decide the question. The Tribunpl his already given the Award. The Award was given, according to my information, some two montns back, but even now the Award has not been published in the gazette as per the requirement? of the Industrial Disputes Act. It is very surprising to me. So, what 1 want to draw the attention of the Government to should publish the Award immediately; (2) They should implement this Award because the Government was also a party to it. When it came to the Supreme Court, the Government also agreed that the employees can go to the Industrial Tribunal and the Award given by the Tribural would be binding on both sides. Now, the Award has already been given by the Tribunal. So, I request the Finance Minister as well as the Labour Minister to look into the matter and have immediate discussion en the question and implement the Award.
