acquired without Government assistance, the company may be allowed to sell such ship as per its commercial judgement.

- (ii) Director General of Shipping/ Shipping Credit and Investment Company of India is satisfied about the reasonableness of the price;
- (iii) the sale proceeds after meeting outstanding liabilities of Shiping Credit and Investment Company of India Government Financial institutions, etc. are kept in a separate account for shipowner to be used only for acquisition of further ships.
- (d) During the last one year, Government accorded permission for 4 such ships to be sold.

## Property Tax Bills in Respect of DDA. Flats in Vasant Kunj, New Delhi...

3331. SHRI KAMAL MORARKA: Will the Minister of HOME AFFAIRS be pleased to state:

- (a) whether it is a fact that DDA flats in Vasant Kunj area parucularly in Sector-D have been allotted and occupied since 1988 but the Municipal Corporation of Delhi has not so far assessed their rateable value and issued property tax bills;

- (d) if so, by when the property tax bills would be issued?

(a) to (d) Property tax notices regarding properties completed or occupied after 1.4.1988 have not been issued so far However, the tax-payers were permitted to pay taxes according to their self-assessment. The process of issue of notices for asses-

sment of these properties shall be completed before 31st March, 1991.
