## CBI Inquiry against a Freedom fighter of Gaya, Bihar

SHRIMATI SURYAKANTA 3381. PATIL: Will the Minister of HOME AFFAIRS be pleased to state:

- (a) whether Government have received a letter from Members of Parliament, dated 7th February and 8th August, 1990 regarding withdrawal of politically moticated inquiry Order of C.B.I, agg against a freedom fighter of Gaya in Bihar;
- (b) whether it is a fact that the then Government had on 6th January, 1988, sent a wireless message to the Collector and Treasury Officer of Gaya to stop the payment of pension to the above freedom fighter and this unwarranted, politically motivated was invalidated by the Hon 'ble Patna High Court and the freedom fighter is drawing his regular pension;
- (c) whether Government ordered the C.B.I, inquiry on the invalidation of the above order and the same is continuing for one year and have not found any irregularity in the grant of pension: and
- (d) if so, the details of the facts in this regard and by when Government would withdraw the inquiry by the C.B.I.?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI SUBODH KANT SAHAY): (a) and (b) In the absence of names of the Hon 'ble Members of Parliament and the details of the case referred to therein, it is difficult to say -whether the references cited have been received by this Ministry.

Presumably the Hon' ble Member is referring to the case of the Swatantrata Sainik Samman Pnsioner of District Gaya (Bihar), whose pension was otopped telegraphically on 7.1.1988. He no doubt, approached the Hon' ble Patna High Court and as per their order, he is getting pension. It is,

## National Hydrographic Institute' at **IWAI Office in Patna**

3384. SHRI CHATURANAN MISH-RA; will the Minister of SURFACE TRANSPORT be pleased to state:

- (a) whether it is a fact that on the occasion of the inauguration of the Indians Waterways Authority of India in the year 1986, it was jointly announced by the then Minister Mr. Rajesh Pilot and the then Chairman Mr. Xavier Arakal that a National Hydrographic Institute biggest in the country would be set up in the campus of the Inland Waterways Authority of India Regional office at Gaigbat in Patna (Bihar); and
- (b) whether, responding to the above announcement the Secretary, Department of Transport, Government of Bihar spontaneously declared that the required land for the pur-pose may be deemed as transferred to the Inland Waterways Authority of India pending execution of formal transferance?

MINISTER OF THE **SURFACE** TRANSPORT (SHRI K. P. UNNIKRI-SHNAN): (a) During the function the Inland Waterways organised by Authority of India on 27th January, 1987 at Patna to inaugurate dredging operations undertaken by them, there was no announcement about the National Hydrographic Institute. There was, however, a mention about establishing a National-level Training Institute ,4n the IWT Sector.
