THE DEPUTY MINISTER IN THE MINISTRY OF FINANCE (SHRI ANIL SHASTRI): (a) to (c) Industrial Development Bank of India (IDBI) has reported that Novopanels India Ltd., was promoted by Novopan India Limited and IPICOL in June, 1987 to set up a plant for the manufacture of particle boards at Pungar, Koraput District, Orissa. The promoters approached the institutions for financial assistance in September, 1989. After discussions the institutions felt that the project would not be support-worthy in view of its being wood based, likely difficulties in procuring rawmaterial and the use of second-hand plant and machinery.

IDBI has further reported that the company THE MINISTER OF TEXTILES WITH has subsequently requested for its application THE to be kept in abeyance.
