108. SHRI ANAND PRAKASH GAUTAM: Will the PRIME MINISTER be pleased to refer to answer to Unstarred Question 439 given in the Rajya Sabha on the 8th May, 1990 and state-

(a) whether the post of PGT and teaching of History, Geography and

Economics will continue to remain in Kendriya Vidyalaya, Moscow even after the closure of Humanities stream; and

(b) if so, what is the justification thereof?

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRI CHIMAN-BHAI MEHTA): (a) and (b) Some

students have offered Humanities stream in class Xi in Kendriya Vidyalaya, Moscow this year and also such, for teaching of History, Geography and Economics, one post each of Post Graduate. Teacher in these subjects will continue to remain in the Vidyalaya.

Increase in the pollution Level as in Rivers in Uttar Pradesh

109. SHRI SHAMIM HASHMI: Will the Minister of ENVIRONMENT AND FORESTS be pleased to state:

(a) whether the Uttar Pradesh Pollution Control Board (UPPCB) has cautioned the State Government about the extreme pollution of the waters of Ganga, Yamuna, Gomti and Varuna; if so, what are the steps taken to control pollution in these rivers;

(b) whether it is also a fact that pollution has reached its maximum in Kanpur, particularly at Guptar Ghat, Jajmaon etc. if so, what steps are being taken to control bacteria contamination beyond permissible levels; and

(c) whether Pollution of Gomti at Lucknow is spreading diseases like Jaundice, Influenza, Gastroenteritis, etc. if so, the corrective steps taken/ proposed?

THE MINISTER OF ENVIRONMENT AND FORESTS (SHRI NILA-MANT ROUTRAY): (a) The Uttar Pradesh Pollution Control Board is regularly reporting to the State Government the water quality status of the Ganga and its tributaries such as the Yamuna and the Gomti. The steps taken to control pollution in these rivers include.

(i) Execution of schemes for interception and diversion of sewage and its treatment in sewage treatment plants before discharge into the rivers.

(ii) Treatment of effluents by major water polluting industries to

prescribed standards before discharge into rivers.

(iii) Legal action against the major defaulters.

(iv) Construction of a Combined Effluent Treatment Plant at Jajmaon for treating effluents from clusters of tanneries.

(b) No, Sir. The pollution level of the Ganga at Kanpur, particularly at Guptar Ghat and at Jajmaon, has improved as compared to the levels in 1987.

(c) No such report has been received.

Global Warming

"(a) whether Government are aware of impending danger of Global warming to our Health as brought out by the noted writer Shri A. T. Dudani in the April, 1990. issue of 'Health-for (Millions)'

(c) whether a Task Force will be set up to monitor and evaluate developments and advise the Government with the involvement of Scientists and other Voluntary Health Groups and involved persons?

THE MINISTER OF ENVIRONMENT AND FORESTS (SHRI NILAMANI ROUTRAY): (a) Government are aware of the article by Shri A. T-Dudani regarding impending danger of Global Warming to human health.

(b) and (c) There is considerable scientific uncertainty about the causes, pace and impact of Global Warming and Climate Change. Government have set up an Expert Advisory Committee, under the Chairmanship of the
