A limited number of berths on trains originating from or passing through stations in drawn up three pronged action Programme the Delhi area has been earmarked as to clear housing back-log in Delhi; emergency quota for dealing with High Official Requisitions and other emergent requests. This quota is jointly controlled by Ministry of Railways and Northern Railway. The number of berths against this quota varies from train to train depending upon the total number of reserved berths available at any particular time, the number of trains run for the same destination, he demand from other sectors viz.

- (c) and (d) The emergency quota is normally released taking into account factors like status of the passenger travelling. nature of urgency of travel like bereavement sickness in the family, etc.
- (e) and (f) No, Sir. The work relating to release of emergency quota is a specialised job and does not require dealing with cash.
