#### **Fire in Toofan Express**

3636. CHOWDHARY HARI SINGH : Will the Minister of RAILWAYS be pleased to state :

(a) whether it is a fact that Toofan Express was set on fire near Karauta (Bihar) on the 10th August, 1990 by anti-reservationists who were protesting against the granting of additional 27 per cent reservation of jobs for backward castes by Government;

(b) if so, what is the loss sustained by the Railways as a result thereof; and

(c) what action Government propose to take in this regard?

THE MINISTER OF RAILWAYS (SHRI GEORGE FERNANDES) : (a) Yes, Sir. One second class coach of Udayan Abha Express (old Toofan Express) was set on fire.,

(b) As a result of this fire, the Rail way suffered a loss of approximately Rupees 2 Lakhs.

(c) The State Government was request ed to make arrangements for the protec tion of passengers, Railway property and smooth movement of Rail Traffic. The Stale Government have strengthened the security arrangements by deploying more GRP/Civil Police and RPF under the charge of Magistrates and Police Officers Mail/Express trains passing through affec ted areas are being escorted by Police/ RPF during the day time also.

#### **E.M.U. Trains on Ahmedabad-Baroda-Surat Sector**
