Supply of salty water in DIZ Area

3574. SHRI A. NALLASIVAN : Will be pleased to state : the Minister of URBAN DEVELOPMENT be pleased to state :

(a) whether it is a fact that water supplied by the NDMC in Sector-4 of DIZ Area is salty:

(b) whether it is also a fact that the residents of this area have to fetch drinking water from the nearby tap installed in Kali Mandir:

(c) whether Government have received any complaint from the residents of this area in this regard; and

(d) if so, what remedial steps Government propose to take to provide fresh and salt-free drinking water to the residents of this Government colony?

THE MINISTER OF URBAN DEVE-LOPMENT (SHRI MURASOLI MARAN) : (a) The supplied water by the NDMC in the DIZ area is not salty. However, the water supplied by the CPWD through the tubewells bored by them to supplement the supplies by the NDMC, which is insufficient due to overall shortage in bulk supply of water in Delhi, though potable, has a saltish taste. in Orissa have been completed :

(b) and (c) Yes, Sir.

(d) In order to make the drinking water available to the residents, the CPWD have provided some taps from the NDMC supply line in all the parks near the blocks. Additional water hydrants have also been installed by the NDMC in various blocks in the area on the request of the allottees.

- (i) Survey for the proposed new railway line from Jakhapura to Paradip.
- (ii) Quick Reappraisal Survey for the proposed Talcher-Barhampur-Gopalpur new line.
- (iii) Updating of the survey for conversion of Rupsa-Bangriposi NG line.

As the Railway already has in hand a number of important surveys, the surveys in Orissa ordered recently will also take some time to complete.
