occasions respectively in the various news bulletins telecast on Doordarshan's national network during the months of May and June, 1990.

(b) The focus in the news coverage is on the importance of the event and not on the individuals. The inclusion of visuals is,, therefore, made strictly on the basis of the news value of the event. Considering the number of news buletins daily telecast in the nationnal nework of Doordarshan, the number of occasions on which the visual coverage of the aforesaid political personalities was included cannot in way be termed to be too frequent.
