Sudmergence of Villages in Madhya Pradesh due to Construction of Rajghat Project

- 454. SHRIMATI RATAN KUMARI: Will the Minister of WATER RESOURCES be pleased to state:
- (a) the number of villages and the total area in Madhya Pradesh that are likely to be submerged on completion of Rajghat Project;
- (b) whether there is any possibilities of submergence of any part of land in Madhya Pradesh from Rajghat Project during the flood season of 1990; and
- (c) if so, what arrangements have been made for payment of compensation and resettlement of oustees by the project authorities and whether required funds have been made available to Madhya Pradesh by the Board?

THE MINISTER OF STATE OF THE MINISTRY OF WATER RESOURCES (SHRI MANUBHAI KOTADIA): (a) 31 villages and 11779 hectares of land.

- (b) In case of occurrence of maximum flood, upto 13 villages may get affected temporarily.
- (c) Payment for land, property and rehabilitation grant to these villages has already been made.

Indian Poultry firms evading Customs duty

- (a) whether it is a fact that owners of certain poultry firms in India are evading Customs duty in the Import of chicks from the United States; and
- (b) if so, what action has been taken by Government against such firms for evading Customs duty?

SHASTRI): (a) and (b) On receipt of information that the owners of certain poultry firms in India were evading Customs duty, the Directorate Intelligence Revenue searched premises of such firms recently. Large number of documents have recovered and 14.459 Chicks valued at Rs. 2.04 crores approximately have been detained.
