the establishment of joint ventures between the USSR and the Indian organisations in the fields of processing tropical fruits, meat processing, citric acid, castor oil and detoxication of castor seed cakes, essential oil etc.

(d) During the Working Group meeting, the Work Plan of Cooperation for the years 1990 and 1991 providing for exchange of visits by scientists and experts, holding of workshops and seminars, supply of hyprids, exchange of fanners, transfer of technologies for agricultural crops, plant genetic resources, bio-technology in plant and animal husbandry, reclamation of saline soils, biological control of pests and insects etc. has been drawn up.

Sabotaging of NDDB's scheme to control prices of edible oils.

548. SHRI SHIV PRATAP MISHRA. Will the Minister of AGRICULTURE be pleased to state:

- (a) whether Government's attention has been drawn to the news item which appeared on p. 16 cols. 5-7, of the Hindustan Times dated the 9th June, 1990, under the caption 'High level lobbies move to sabotage NDDB move, according to which NDDB's scheme to ensure reasonable prices for consumers and remunerative prices for growers of oilseeds is sought to be sabotaged by vested interests; and
- (b) if so, the remedial measures taken by Government in this regard?

THE MINISTER OF STATE IN THE DEPARTMENT OF AGRICULTURE COOPERATION ΙN THE MINISTRY OF AGRICULTURE (SHRI NITISH KUMAR): (a) Yes, Sir.

(b) Under the terms for Market Intervention in edible oils and oilseed, NDDB which has been appointed as the Market Intervention Agency, has been given full functional autonomy to achieve the objectives of the market intervention operations. The NDDB were given an

allocation of 50,000 tonnes of imported, palmolein for market intervention operations during 1989-90. In addition, a further allocation of one lakh tonnes of imported palmolein is being made against exports of milk powder and milk products by NDDB and this additional import will greatly assist the market intervention operations in combating the price increase in edible oils.

- (घ) इस संबंध में प्रति वर्गमीटर किकास शल्क की दर तथा अन्य ब्योरा क्या है; और क्या प्रति वर्गमीटर भूमि की दर में 475/- रूपये तक कमी करने में कोई कठिनाई है, यदि हां, तो उसका ब्यौरा क्या है?
