#### 691. SHRI KAMAL MORARKA: DR. BAPU KALDATE: SHRI YASHWANT SINHA:

Will the Minister of FOOD AND CIVIL SUPPLIES be pleased to state:

- (a) whether it is a fact that the PESB had recommended an extension of tenure for Mr. S.C. Kapoor, Chairman, Hindustan Vegetable Oil Corporation (HVOC);
- (b) whether in spite of the PESB recommendation, his term was not extended and he was asked to handover charge preemptorily;
- (c) whether it is a fact that during Mr. Kapoor's tenure HVOC turned around from loss-making to profit making enterprise; and
- (d) if so, the reasons for not extending his tenure?

THE MINISTER OF STATE IN THE MINISTRY OF FOOD AND CIVIL SUPPLIES (SHRI RAM PUJAN PATEL): (a), (b) and (d) PESB had recommended the extension of tenure of Shri S.C. Kapoor. The matter regarding extension was, however, carefully considered by the Government from all angles including administrative and vigilance angle and it was not considered desirable to extend his tenure further in public interest.

(c) In monetory terms, HyOC made profits, though production of vegetable

oil (vanaspati) had gone down considerably.

#### Accident of Bombay Bound Holiday Special Train
