**Downfall in Cultivation of Oilseeds**

(b) if so, the State-wise/production-wise details thereof;

(c) whether Government are going to provide all the facilities to the agriculture based industries, alongwith other concessions, for massive investment in the field of oilseeds; and

(d) if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI HUKUMDEO NARAYAN YADAV):

(a) There has been a 38.77 per cent down fall in the production of

oilseeds during 1999-2000 as compared to the production in the year 1998-99. This down fall in production is due to severe drought prevailing and attack of pests and diseases on oilseed crops in some of the major oilseeds growing states.

(b) State-wise total production of oilseeds during 1998-99 and 1999-2000 is given in the enclosed Statement (See below).

(c) and (d) The processing industrial units of oilseeds into oil and other derivatives are entitled to get a grant of 25% of the cost of plant and machinery and technical civil work to the maximum of Rs. 50.00 lakh in general area and 33.3% to the maximum of Rs. 75.00 lakh in difficult areas under the plan schemes of Ministry of Food Processing Industries, if it involves use of the latest technology and process which enhances recovery, improves quality, ensures by-product utilization and other benefits leading to substantial value addition.
