Ill effects on passive smokers

1362 SHRI JOHN F. FERNANDES: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

(a) whether Government are aware that cancer can be caused even to a passive smoker who accidentally inhales smoke exhausted by other smokers;

(b) if so, whether Government would consider banning smoking in Government offices and public places to begin with; and

(c) what other steps Government contemplate to eradicate this hazard?

THE MINISTER OF STATE OF THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRI RASHEED MASOOD): (a) Yes, Sir.

(b) and (c) In order to protect the non-smoking public, from the hazards of passive smoking instructions have been issued to prohibit tobacco smoking to start with, in a few selected places, namely, hospitals, dispensaries and other health care establishments, educational institutions, conference rooms, domestic airflights, air-conditioned chaircars and air-conditioned sleeper coaches in trains, suburban trains and air-conditioned buses. An anti-smoking legislation is also under consideration of the Government,
