

SHRI ANANTH KUMAR: Actually the ground water level is depleting all over the country. It is more so where the urbanisation is growing at a very rapid rate, especially where we have created almost concrete jungles. The Urban Development Ministry has been requesting and suggesting to various State Governments as well as the urban local bodies to go in for rainwater harvesting so that the depleting ground water level can be maintained at a sustainable level.

THE DEPUTY CHAIRMAN: We are doing that in Delhi and Gujarat now.

PROF. (SHRIMATI) BHARATI RAY: Actually my question has been asked by my previous speaker. I will, therefore, put a simple question. What are the factors that you take into account while deciding on the total requirement of potable water?

Secondly, how long do you think it will take to make Delhi supply to come up to 800 million gallons a day?

SHRI AN ANTH KUMAR: Various projects are underway for augmentation of Delhi water supply. They are: Chandrawal No. 2, Wazirpur No. 3, Hyderpur, Bhagirathi, Dwarka, Nangloi, Bawana, Sonia Vihar...

PROF. (SHRIMATI) BHARATI RAY: You have already stated that. How long will it take to come up to 800 million gallons a day?

SHRI AN ANTH KUMAR: Madam, the question is right, but the address is wrong. I will put this question to Delhi Jal Board under the Delhi State Government. But, on behalf of it I can answer this question that it may take next five years.

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DR. (SHRIMATI) RITA VERMA): (a) and (b) The persons enrolled on the State Medical Register or Central Register of Indian Systems of Medicine can practise Indian Systems of Medicine only. However, such persons can also practise modern medicine to the extent permitted by a general or special order issued by the State Governments in this behalf.

**Shortfall in realisation from disinvestment**

\* 102. SHRIMATI VANGA GEETHA: Will the Minister of DISINVESTMENT be pleased to state:

(a) the shortfall in realisation from disinvestment in the last three years;

(b) the estimates for the next two years; and

(c) the measures being taken to expedite the disinvestment programme?

THE MINISTER OF DISINVESTMENT (SHRI ARUN SHOURIE): (a) The receipts and the shortfall of disinvestment during the last three years, against targets fixed are given below:—

(b) For the current year, *i.e.* 2001 -2002 the target is fixed at Rs, 12,000 crore. No precise estimate about receipts can be made for the next two years.

(AI), Bharat Heavy Plates and Vessels Ltd. (BHPV), Computer Maintenance Corporation Ltd. (CMC), Engineering Project (India) Ltd. (EPIL), Hindustan Cables Ltd. (HCL), Hindustan Copper Ltd. (HCL)—Phase I, Hindustan Organic Chemicals Ltd. (HOCL),
