Creation of a centralised cell to receive complaints against Inspectors of Small Scale Industrial Units

1258. SHRI THOMAS KUTHIRAVATTOM : Will the Minister of INDUSTRY be pleased to state :

(a) whether Government's attention have been drawn to the news item captioned "Government to free small sector from inspector raj" which appeared in the Indian Express dated the 7th August, 1990 ;

(b) if so, whether Government propose to create a centralised cell at the Central and State levels where complaints against the Inspectors could be lodged ; and

(c) if so, what effective steps are contemplated in this regard?

THE MINISTER OF STATE IN THE DEPARTMENT OF SMALL SCALE INDUSTRIES AND AGRO AND RURAL INDUSTRIES IN THE MINISTRY OF INDUSTRY (SHRI SRIKANTA JENA) : (a) Yes Sir.

(b) and (c) The Government has recently constituted a Committee under the Chairmanship of Joint Secretary, Department of Small Scale Industries & Agro and Rural Industries in the Ministry of Industry to look into the matter of unnecessary interference by Inspectors visiting the Small Scale Industrial Undertakings under various Acts/Laws and make suitable recommendations to the Government with a view to eliminate the same. The terms of the reference of the Committee are :

1. To examine the possibility of exempting the Small Scale Sector from the application of certain Acts.

2. In respect of Acts which have to be applicable to consider the possibility of combining the relevant forms/returns with a view to drastically reducing their overall numbers.

3. To cut down significantly on the visits of the Inspectors under the various Acts, including reducing their frequencies.
