- (b) The NCR Planning Board Act, 1985 envisages evolving harmonised policies for the control of land uses and development of infrastructure in the National Capital Region so as to "avoid any haphazard development thereof. In order to achieve this objective the Regional Plan 2001 proposes policy of giving impetus to the Regional Centres through provision of adequate infrastructure and services.
- (c) As reported by the Ministry of Petroleum andNatural Gas, there is no proposal to set up stations outside the NCT of Delhi in addition to what is already existing. Currently, all CNG vehicles are taking CNG from the existing stations.
- (d) and (e) The introduction of low sulphur in NCR of Djelhi is as per direction of the Hon'ble Supreme Court to control pollution. The hike in price is a natural sequel to this as some further processing is involved for conversion of diesel with higher sulphur content to a quality with lower sulphur content. In the NCR there is no discrimination between the agriculturists and non-agriculturists in so far as the prices are concerned.

An amount of Rs. 100 crores has been sanctioned in favour of Municipal Corporation of Delhi (MCD) for construction, improvement and strengthening of roads in Delhi to improve the urban
