(c) whether it is also a fact that 150 plastic units are sick due to the above policy in Gujarat ; and

(d) what are the reasons for not allowing plastic bags for fertilizer and cement industries ?

THE MINISTER OF TEXTILES WITH ADDITIONAL CHARGE OF THE MINISTRY OF FOOD PROCESSING INDUSTRIES (SHRI SHARAD YADAV) • (a) Permission for import of raw jute is available to all exporters of jute goods under the Advance Licensing Scheme for meeting their specific requirement of raw materials at Internati nally competitive rates for fulfilment of their export commitments.

(b) In terms of the Reservation Orders issued by the Government under the provisions of the Jute Packaging Materials (Compulsory use in Packing Commodities) Act, 1987 all fertilizer factories are required to pad their entire urea production in jute bags only. In the case of the cement units the Reservation Orders stioulale that the unit located within 1200 kilometres from Calcutta should pack 70% of their production in jute bags and those 1 cated beyond 1200 Idlometres should pack 65% of their production in jute bags.

(c) No, Sir.

(d) Government have given in terms of the Reservation Orders sufficient scope for the plastic bags sector to serve the interests of the cement and ferilizer industries by having a reasonably legitimate share of their productson. In the case of the fertilizer sector while urea pack, aging is to be done in jute bags only all other varieties have been left free for bemg packed in any bag.
