. एक ग्रौर प्रैक्टिस करलें कि ग्राज से ग्राठ महीने पहले कितने कार्ड बने थे - तो उनको सत्य का पता चल जाएगा। यह वास्तविकता है कि इतने कार्ड बने हैं. 70 करोड की जनसंख्या इसमें कवर हुई है, लेकिन इनमें बोगस कार्ड की संख्या बहुत ज्यादा है । मैं ग्रापको बताऊं कि जिस शहर की जनसंख्या दस लाख. है, जैसे भोपाल की जनसंख्या दस लाख है ग्रौर ग्रांकड़ा यह है कि भोपाल में सात लाख कार्ड बने हैं, इनमें से लगभग तीस-पैतीस परसेंट बोगस कार्ड हैं। ग्रब जरा इस पर माननीय मंत्री जी बता दें कि यह कब बने थे ग्रौर किस सरकार के दौरान बनाए गए हैं ? इससे पता लग सके कि इस सबकी वास्तविकता क्या है ?

श्री सभापति: मंत्री जी, श्राप इसका पता लगा लीजिए कि क्या ऐसा है ग्रीर खासतौर से भोपाल का देदीजिए?

श्री राम पूजन पटेल : माननीय सभा-पति जी. जैसा माननीय सदस्य ने बताया है, उसकी जांच करवा ली जाएगी।

Improvements in the Cuttack Railway Station

KAHNU *225. SHRI CHARAN LENKA: Will the Minister of RAIL-WAYS be pleased to state:

- (a) whether there is any proposal under Government's consideration make improvements in the Cuttack Railway Station;
- (b) if so, the steps taken in that regard; and
- (c) the funds provided for the purpose?

THE MINISTER RAILWAYS OF (SHRI GEORGE FERNANDES): (a) Yes, Sir.

(b) and (c) The following works in this regard are in progress|sanctioned at Cuttack:

A provision of Rs. 5 lakhs has been made for all these works during 1990-91.

SHRI KAHNU CHARAN The total amount sanctioned for decylopment of the Cuttack Railway Station is about Rs. 25 lakhs. has been stated by the Minister. Looking to the needs for the development of the Station, it is a very meagre amount. Sir, Cuttack station is 100 years old and its population during this period has increased hundred times. Hundred years ago its population was 10,000 and now it is more than 10 lakhs. Hundred years back there were two platforms and today also the number of the platforms is the same.

MR. CHAIRMAN: Do you want more platforms?

SHRI KAHNU CHARAN LENKA: The number of passengers has increased 100 times and there is no seating provision for the passengers in the waiting rooms. There is no space for parking vehicles outside the station. No improvement has been made there for last 42 years since independence. Minister has also stated that a provision has been made for installing indicators for incoming and outgoing trains, but I may tell you up till now there are no such indicators.

MR. CHAIRMAN: What do you What is your question?

SHRI KAHNU CHARAN LENKA: Keeping in view the hazardous condition at the station, I would like to know whether the Government will take up a scheme to expand and increase the number of platforms and modernise the stations with all the amenties that are available in A Class stations.

श्री शांति त्यागी : जैसा दिल्ली में है, ऐसा बनाग्रो । दिल्ली जैसा बनाग्रो ।

SHRI AJAY SINGH: For the information of my hon, colleague I will read out the facilities that are available there.

MR. CHAIRMAN: His first question is, will you think of having more platforms?

SHRI AJAY SINGH: That is what I am trying to answer. The hon. Member said there are only two platforms, but actually there are three. One of the platforms has already been sanctioned for raising.

SHRI KAHNU CHARAN LENKA: There is no existence of platform No. 3. It is on paper. There is no addition or expansion of platforms there up till now.

MR. CHAIRMAN: There seems to be a confusion. I can explain it to you. One side of the platform is counted as platfrom No. 1 and the other side as platform No. 2. That is a fact. You can go to the Delhi station and find out.

SHRI KAHNU CHARAN LENKA: I want to know from the Minister on what basis this estimate has been made and on what basis this amount has been sanctioned. There is no indication of the basis. It has also not been indicated by what time this amount of Rs. 25 lakhs will be spent.

श्री सभापति : ग्राप ग्रौर क्षेटफार्म बनाग्रोगे ?

श्री प्रमोद महाजन: ग्रभी एक करेंगे तो तीन के पांच हो जाएंगे।

श्री सभापति: सं किण्ड सप्लीमेंटरी।

SHRI KAHNU CHARAN LENKA: Sir. the Minister has not replied to my first question. So, what can I ask in my second supplementary? Anyhow, in my second supplementary. I would ask if he would consider my proposal to modernise the Cuttack station?

MR. CHAIRMAN: He will consider it.

SHRI BASUDEB MOHAPATRA: Mr. Chairman, Sir, I would like to know from the hon. Minister a specific ques-In the year 1987-88 67 railway stations were selected for development as model stations. Work in respect of some of the stations has already been completed and some are in progress. But one major station, Cuttack has been left over. The hon, Minister during his last visit to Orissa in the month of January had assured that Cuttack railway station will be developed as a model station and modernisation and electrification of railway track from Cuttack to Bhubaneshwar would be taken up immediately. May I know from the hon. Minister whether the Government has any plan to take up some more stations as model stations as has been done in 1987-88? If that is so, then, will Minister consider to include Cuttack railway station also as a model station?

SHRI AJAY SINGH: Mr. Chairman, Sir, 67 stations were taken up for development as model stations and the Government at this stage does not have any other stations in mind for development until these are covered.

SHRI SARADA MOHANTY: Mr. Chairman, Sir, may I know from the

minister whether the Government would consider introducing computerisation at Cuttack railway station very soon?

SHRI AJAY SINGH: Mr. Chairman, Sir, computerisation facility is proposed to be extended to Cuttack in this year.

SHRI BASANT KUMAR DAS: Mr. Chairman, Sir, the hon. Minister has said about the development of Cuttack railway station and recently I asked a question on that. They have said something about phasing in the South-Eastern Railway. I want to know from the Government whether they are going to make a comprehensive plan to develop all the old railway stations which are at least 25—50 years old.

MR. CHAIRMAN: Have you any plan to improve old stations which are 50 years old?

SHRI AJAY SINGH: Normally surveys are conducted throughout the year. At present there is no such specific suggestion.

Enhancement of regularisation charges of unauthorised colonies in Delhi

- (a) whether it is a fact that the regularisation charges of unauthorised colonies in the Capital have recently been enhanced by 500 per cent with out any approval;

- (d) what action is proposed to be taken against the officials responsible for such enhancement without approval of the competent authority?

THE MINISTER OF URBAN DE-VELOPMENT (SHRI MURASOLI MARAN): (a) No, Sir.

(b) to (d) Do not arise in view of a reply to Part(a) above.

SHRI MURASOLI MARAN: Sir, there has been no enhancement at all in the development charges levied. For a long time Rs. 110 per sq. mctre has been charged. Even this amount is very, very small if you compare with the actual cost. The hon. lady Member wants an assurance whether the same rates will continue. Sir, it is very difficult to give an assurance in this regard. We have to take into account the cost and other factors.

श्रीमती सूर्यकांता पाटील: मेरा जवाब तो नहीं ग्राया सर, ठीक है। मेरा सैकिंड सप्लीमेंटरी है—राजधानी दिल्ली में बसी हुई ग्रनाधिकृत कालोनियों में से कितनी कालोनियों को सरकार ने ग्रधिकृत करार दिया है ? ग्रगर ग्रधिकृत करार दिया गया है तो किन-किन नियमों के तहत उन कालोनियों को ग्रधिकृत करार दिया है ?

मेरे प्रश्न का "बी" पार्ट ग्रगर नहीं तो भविष्य में सरकार इस तरह से बसी हुई ग्रनाधिकृत कालोनीज को किस तरह ग्रधिकृत करना चाहेगी ?

MR. CHAIRMAN: Question Hour is over.
