## Linking of edible oils producing and consuming centres by NDDB

1970. SHRI BASUDEB MOHAPATRA: Will the Minister of AGRICULTURE be pleased to state:

- (a) whether it is a fact that National Dairy Development Board (NDDB) is strengthening its National Oil grid by linking the producing and consuming centres by tank for storage of edible oils and oilseeds all over the country; and
  - (b) if so, what are the details thereof?

THE MINISTER OF STATE IN THE DEPARTMENT OF AGRICULTURE AND COOPERATION IN THE MINIS-TRY OF AGRICULTURE (SHRI NITISH KUMAR): (a) and (b) Under the NDDB's Oilseeds Growers' Cooperative Project (OGCP) and its market intervention operations, facilities are being created for storage of edible oils and oilseeds at important market centres and producing zones. Edible oil and oilseeds storage facilities have been created by the Oilseeds wers' Unions and Federations at major producing zones in all the seven States under NDDB's OGCP. Work is in progress in Delhi and Kandla where NDDB is building edible oil tank farms to meet the requirement of storing edible oil.

# Shifting of Central Government offices to Ghaziabad, Uttar Pradesh

1971. SHRI RAM AWADHESH SINGH: Will the Minister of URBAN DEVELOPMENT be pleased to state:

- (a) whether it is a fact that Government owns a big plot of land near Shastri Nagar and Govindpuram in Ghaziabad to accommodate some Central Government Offices; and
- (b) if so, the names of such offices and by when these offices are likely to be shifted there?

THE MINISTER OF URBAN DEVE-LOPMENT (SHRI MURASOLI MARAN): (a) Yes, Sir.

- (b) The offices to be shifted include:
  - 1. Telecom Training Institute
  - 2. Postal Staff College
  - 3. National Test House
  - 4. C.S.I.R. Research Institute (SERC)
  - 5. Pharmacopocial Laboratory of Indegenous Medicine
  - 6. C.P.W.D. Training Institute

besides, such other offices as may be decided by the Government. No firm date for shifting can be indicated since this would depend on completion of buildings and other requisite arrangements.

# Wage negotiation in the Central Warehousing Corporation

1973. PROF. SOURENDRA BHAT-TACHARJEE: Will the Minister of FOOD AND CIVIL SUPPLIES be pleased to state:

- (a) whether Regional Labour Commissioner, Delhi have instructed the Central Warehousing Corporation authority to start wage negotiaions with the Federation of Central Warehousing Corporation employees; and
- (b) if so, what is the latest position in this respect?

THE MINISTER OF STATE IN THE AND CIVIL MINISTRY OF FOOD RAM **PUJAN** SUPPLIES (SHRI PATEL): (a) and (b) In an industrial dispute raised by Federation of CWC Employees Union, Regional Commissioner (C), New Delhi has admanagement of CWC that pending their request to Central Labour Commissioner for verification etc. they should not by their actions create impression that they are encouraging one or the other Union on the cost of Federation.

However, the Corporation has already had several rounds of discussions with the Federation of CWC Employees Union in connection with wage settlement of Group 'C' & 'D' employees of the Corporation. Final Settlement will, however, require further discussions.

#### Apprehending of ticketless passengers

1974. SHRI B. K. HARIPRASAD: Will the Minister of RAILWAYS be pleased to state:

(a) how many ticketless travellers were apprehended, all over the country, State-wise during 1988-89;

- (b) how many were prosecuted indicating the sums realised and persons sent to Jail;
- (c) how much money was spent on detection, enforcement and court cases and detention in Jails;
- (d) whether the economic status of these offenders has been found out and if so, the details thereof; and
- (e) whether Government would consider other measures for prevention of ticketless travel including improvement of travellers?

THE MINISTER OF RAILWAYS (SHRI GEORGE FERNANDES): (a) and (b) State-wise figures are not maintained. A statement giving Zone-wise information is attached [See Appendix CLV, Annexure No. 60]

- (c) and (d) Separate statistics in this regard are not maintained.
- (e) In order to curb ticketless travel, surprise checks including magisterial checks are conducted in association with Government Police Railway Railway Protection Force. The hazards and consequences of ticketless travelling are highposters notices at lighted by display of Railway Stations, through information published in Railway Time-Tables and advertisements in newspapers, by display of short films in cinema halls and on television and by making frequent announcements on public address system at important stations.
