2288. SHRI THOMAS KUTHIRAVAT-TOM: Will the PRIME MINISTER be pleased to state:

- (a) whether it is a fact that overtime allowance to Central Government Employees has been dispensed with as per the recommendation of the last Pay Commission;
- (b) whether it is still being paid very liberally to the staff members attached to the Ministries; and
- (c) whether the Ministry would issue orders to abolish overtime allowance to these categories also in view of the economic drive launched by Government?

THE PRIME MINISTER (SHRI VISH-WANATH PRATAP SINGH) (a) to (c) The recommendations of the Fourth Pay Commission that the system of payment of overtime in Govt, offices may be discontinued has been accepted by the Govt, and the modalities of implementation of the recommendations are in the process of finalisation. In the meantime in exceptional cases where compensatory offs cannot be given and the stay beyond office hours becomes unavoidable, compensation for extra work is being paid according to the exi'sting orders on the basis of national pay admissible to concerned employees in the pre-revised scale of pay|s!ab and it is subject to same terms and conditions as laid down in the existing orders. The amount of overtime paid to staff attached to different ministries is not being centrally monitored.

- (a) to (f) The Indian Institute of Science is a Demand University and is managed by an independant Governing Council. Introducing second M. A. Economics Programme in Jawaharlal Nehru University

2290. SHRI SAMAR MUKHERJEE: Will the PRIME MINISTER be pleased to state:

- (a) whether the Jawaharlal Nehru University, New Delhi is proposing to start a second M. A. Economics programme in its School of International Studies:
 - (b) if so, the details thereof;
- (c) what are the reasons for having two parallel programmes on the same subject in the University;
- (d) how much additional resources would be required for the proposed pro gramme;
- (e) whether an attempt has been made at, a rationalisation of the present pro gramme to correct any perceived imba lances to save scarce resources; and
- (f) whether any discussion has taken place in, the A^cfdemjc Council ^cf the said University, if so, the details thereof?

THE MINISTER OF STATE IN THE MINISITRY OF HUMAN RESOURCEI DEVELOPMENT (SHRI CHIMANBHAI MEHTA): (a) to (f) Yes, Sir. Jawahar-lal Nehru University has decided to institute M. A. (International Economics) programme in the School of International studies of the University.

According to the information furnished by the University, the newly instituted M. A.

(International Economics) programme is not parallel to the one being offered by the School of Social Sciences as the thrusts of the two programmes are at variance with each other as also the course structure. However, when the matter was discussed by the Academic Council of the University in its meeting held on 11-5-90, the V ice-Chancellor stated that while formulating the course contents for the newly instituted M. A. (International Economics) programme, the School of International Studies may hold consultation with the School of Social Sciences with a view to avoiding duplication and overlapping to the extent feasible and also to ensure that available expertise is put to optimum use*

The University has not finalised the; financial requirement for starting the programme.

- (a) whether it is a fact that an international conference on environmental protection of the Himalayas was held in Delhi in April, 1990; and

THE MINISTER OF ENVIRONMENT AND FORESTS (SHRI NILAMANI ROUTRAY): (a) No, Sir. The said Conference was held in Delhi on 30th-31st March, 1990, by the Himalayan Adventure Trust, New Delhi in collaboration with the Indian Mountaineering Foundation.
