THE PRIME MINISTER (SHRI VISHWANATH PRATAP SINGH): (a), (b), (e) and (f) The Central Secretariat Service consists of the following four grades: -

- (i) Selection Grade (Deputy Secretary and equivalent posts);
- (ii) Grade-I (Under Secretary and equivalent posts);
- (iii) Section Officer's Grade (Group B Gazetted); and
- <iv) Assistant's Grade (Group B Non-Gazetted).

The posts of Selection Grade (Deputy Secretary and equivalent posts) and Grade-I (Under Secretary and equivalent posts) are centralised and form part of the Central Staffing Scheme. The appointment of eligible Central Secretariat Officers to these posts are made on the basis of certain specified guidelines along with the officers oft he All India Services and the Central Services. As no specific post is earmarked for members of the Central Secretariat Service, the question of having a cadre review in respect of these grades for the members of the Service does not arise.

The Section Officers' Grade and the Assistant's Grade are decentralised and

- controlled by the different Cadre Controlling Authorities. Instructions have been issued to the Cadre Controlling Authorities to carry out the cadre review of the decentralised grades of Central Secretariat Service.
