(c) above be in affirmative whether Government would consider restoration of commuted portion of pension after 10 years or enhance the commutation value commensurating with the prevalent rate of interest and mortality rate?

THE **PRIME MINISTER** (SHRI VISHWANATH PRATAP SINGH): (a) to (d) Commutation value of pension is calculated on the basis of a Table of Values prescribed under the Commutation Rules. These values are based on life expectancy and the rate of interest on Government borrowings. The present commutation table is in force from 1971 and is inter-alia based on a rate of interest of 4. 75 per cent, if the Commutation Table is revised on the basis of current rate of interest, despite the increase in life expectancy, it will have the effect of lowering the commuted value.

It is not correct to say that the commuted value represents "sum total of approximately 10J years" pension nor is it to be treated as an advance payment of pension. Where a pensioner dies even immediately after receiving the commuted value, the amount is retained by the family and no recovery is involved. In the case of those who retire before attaining the age of 58 years, though a higher commuted value is paid the commuted portion of the pension is restored uniformly after 15 years. Taking all factors into account as also the fact that the commuted value of the pension is by and large repaid after a period of 15 years on an average, the Supreme Court directed that the commuted portion of pension should be restored after 15 years from the date of commutation. It is not considered necessary to make any change in this regard.
