THE MINISTER OF STATE IN THE MINISTRY OF PLANNING AND THE MINISTER OF STATE IN THE MINISTRY OF PROGRAMME IMPLEMENTATION (SHRI BHAGEY GOBARDHAN); (a) Yes, Sir.

- (b) District-wise details of number of persons living below poverty line in Andhra Pradesh are not available.
- (c) No, Sir, As per NSS Consumer Expenditure Survey, the number has gone down from 217.4 lakh in 1977-78 to 195.05 lakh in 1987-88 as can be observed from the data given below:

### Creations of Posts in Universities
