Induction of new Aircraft by I. A. F due to delay in LCA project

*269. SHRI SURESH KALMADI: Will the PRIME MINISTER be pleased to state:

- (a) whether it is a fact that the IAF intends to induct a new strike aircraft because of the delay in the Light Combat Aircraft;
- (b) what are the reasons for delay in the LCA Project; and
- (c) by when the LCA prototype would be ready and it would come with squadron service?

THE MINISTER OF STATE IN THE MINISTRY OF DEFENCE (DR. RAIA RAMANNA): (a) No, Sir. However, phasing out of old aircraft and planning for the induction of new aircraft is an ongoing process and is related to the operational requirements of the IAF.

(b) The design and development of a technically advanced aircraft like the LCA involves the integration of complex technologies, complex interface management between a number of expert establishments and the absorption of selected state-of-the-art technologies from advanced countries. The time taken for the identification, evaluation, acquisition and absorption of selected technologies and the lack of advanced infrastructural facilities for optimisation and evaluation of the LCA configuration have also contributed to the d»la_v in project execution. The time taken in fina-Iisin<r the strategy for the post Project Definition Phase (PDF) activities in consultation with all concerned establishments, together with the resources crunch, have contributed the delay. also

(c) The roll-out of the first LCA core technology demonstrator platform is expected in 1995. The LCA is likely to enter squadron service early in the next decade.

(b) The post of Vice-Chancellor, Aligarh Muslim University, fell vacant on 4-10-1989. According 'to Statute 2(1) of the Statutes of Aligarh muslim University, the Vice-Chancellor of the University is to be appointed by the Visitor from a panel of at least three persons recommended by the Court from a panel o[^] five persons recommended by the Executive Council. It has not been possible to appoint a Vice-Chancellor because the Court has not recommended any panel to the Visitor (President of Tndia) for appointment of the Vice-Chancellor
