- (b) if so, what is the present strength of Indian Coast Guard ships and the guns on them, as compared to those of their counterparts in Pakistan; and
- (c) what is the scheme for upgrading and augmenting the Indian Coast Guards fleet equipment so as to be able to guard the coastal belt effectively?

THE MINISTER OF STATE IN THE MINISTRY OF DEFENCE (DR. RAJA RAMANNA): (a) and (b) The recently acquired Pakistani Maritime Agency vessels are equipped with modern 30 mm guns. Our Coast Guard vessels are equipped with the older 40/60 Bofors guns. The strength of Coast Guard Fleet and their fire power are determined according to the roles assigned to the Coast Guard vessels.

(c) The augmentation of Coast Guard Fleet and its modernisation are undertaken in accordance with the Coast Guard Development Five Year Plans.

Alleged misleading of Swedish Newspaper "Degens Nyheter" by investigation team in Bofors Gun deal

- (a) whether it is a fact that the Swedish Newspaper DEGENS NYHETER has tendered an unqualified apology to Shri Ajitabh Bachchan in a libel suit filed by him against the newspaper for publishing a report, linking him with the Bofors Gun deal;
- (b) whether it is also a fact that in the proceedings, the said newspaper had blamed the CBI and the persons directly involved in the investigations into the deal on behalf of Government of India, for mis-

leading both the correspondent and the editor of the newspaper; and

(c) if so, what are the names of such persons who have misled the Swedish newspaper?

THE MINISTER OF STATE IN THE MINISTRY OF DEFENCE (DR. RAJA RAMANNA): (a) The Ministry of Defence has no information in the matter.

(b) and (c) According to the CBI, no officer of the Government of India who was associated with the investigation at any stage had anything to do with the story published by Degens Nyheter on 31-1-1990.
