Departmental test for promotion of peons in Delhi Municipal Corporation

2*27. SHRI CHATURANAN MISHRA: Will the Minister of HOME AFFAIRS be pleased to state:

(a) whether a departmental test was conducted for the promotion of peons in Delhi Municipal Corporation in 1988-

(b) if so, whether any quota for Scheduled Caste and Non-Scheduled Caste has been fixed; if so, the details thereof;

(c) whether it is a fact that the candidates who, got 33 per cent marks were declared passed in 1988 but the candidates who secured 46 per cent marks were declared failed; if so, the reasons therefor; and

(d) whether a panel of the passed candidates has been prepared^ if so, the details thereof and for how many years the same is valid?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI SUBODH KANT SAHAY): (a) Yes, Sir.

(b) The quota for Scheduled Caste and Scheduled Tribe candidates was fixed in recruitment to the posts of L. D. Cs. as per Government of India's instructions.

(c) Only candidates, obtaining 47% marks or more were included in the panel

(d) All 126 candidates included in the panel have been appointed to the posts of L. D. Cs.

(v) Inclusion of 1200 cargo handling workers in the New Mangalore Port Trust Cargo Handling Workers (Regulation of Employment) Scheme, 1990.
