THE MINISTER OF SURFACE TRANSPORT (SHRI K. P. UNNI-KRISHNAN); (a) The Task Force constituted to assess the damages to National Highways in Andhra Pradesh has assessed the same to be of the order of Rs. 5. 03 crores. For other roads, the State Government has reported a damage of Rs. 234. 985 crores to the Central Team deputed by the Ministry of Agriculture.

(b) to (d) A sum of Rs. 50. 00 lakhs was released on ad hoc basis for urgent repairs to the National Highways. Ministry of Agriculture has also released Rs. 64. 50 crores to Andhra Pradesh State to undertake all relief measures and incur necessary expenditure in the wage \*\* the natural calamity,

- (d) A Member of the said Editorial Board made a suggestion that the matter might be more appropriately referred to it for advice.

#### **AIR Network in Andhra Pradesh**

Inner Line Permit for Mizoram and Nagaland

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI SUBODH KANT SAHAY): (a) to (d) Mizoram and Negaland declared have been as Protected Areas under the Foreigners (Protected Areas) Order, 1958, and Meghalaya has been declared as Restricted Area Foreigners under the (Restricted Order, Areas) 1963. All foreigners. other than citizens of Bhutan, require permits to enter these areas. Under the Bengal Eastern Frontier Regultaion, 1873, Indian citizens, not normally resident in certain parts of Nagaland and Mizoram, also require permission to visit these areas.
