THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI SUBODH KANT SAHAY): (a) Government is aware of Pakistan's involvement in aiding and abetting the subversives and secessionists in the State of Jammu and Kashmir.

- (b) Government of Jammu & Kashmir has advised that 1625 persons were apprehended upto 31st July, 1990 in the State, out of which 475 persons were released after preliminary verifications
- (c) Government is seized of the matter and have taken a number of steps to avoid such incidents which include deployment of more para military forces in sensitive areas and increased surveillance on the border.
