Whereas Kharapathar is expected to receive TV service from the high power (IKW) TV transmitter under* Implementation at Shimla subject to local topographical conditions, there is no approved scheme at present to set up a separate TV transmitter at Kharapather. It is the endeavour of the

Government to further improve TV service in the area, as expeditiously as possible, but this Bhall depend upon the availability of funds for the purpose.
