Decline in deposits of regional rural Banks

In order to give further boost to the deposits In Regional Rural Banks, Central Government have advised State Governments that State agencies functioning at District levels should keep their deposits with PRBs to the extent feasible. Reserve Bank of India has also advised the sponsor banks to involve RRBs in work relating to Rural Publicity for improving customer service which may help in mobilising more rural deposits.
