ensure harmonious and quick implementation, it has been decided to adopt in the first phase the castes common to both the Mandal list as well as the State Lists.

The percentage of reservation for the Socially and Educationally Backward Classes (SEBCs) will be 27 per cent.

This reservation will be applicable to services under the Government of India and Public Undertakings with effect from 7-8-1990.

Amendment to the Inter-State Migrant Workers' Act
