- (b) if so, whether permission has been given; and
- (c) if not, when it will be given?

THE MINISTER OF STATE IN THE DEPARTMENT OF ATOMIC ENERGY (SHRIMATI VASUNDHARA RAJE): (a) to (c) The agency for setting up of Atomic Power Plants in India (including at Kaiga, in Karnataka) is Nuclear Power Corporation of India Ltd. (NPCIL), under the Department of Atomic Energy (DAE), Government of India. Proposals for Nuclear Power development in the Ninth Five Year Plan *inter-alia* include commencement *of* work on two units of Kaiga i.e. Units-3 & 4 (2 x 220 MWe).

## Storage and handling cost of Foodgrains by FCI

1285. SHRI R.P. GOENKA: Will the Minister of CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION be pleased to state:

- (a) what is the cost of storage and handling grains by the Food Corporation of India;
  - (b) how does this cost compare with costs in the private sector;
- (c) whether it is a fact that the price of foodgrains from public distribution system to non-BPL consumers is more than the price in the open market; and
- (d) whether Government have any intention to privatise storage and handling of grains?

THE MINISTER OF STATE IN THE MINISTRY OF CONSUMER AFFAIRS AND PUBLIC DISTRIBUTION (SHRI SHRIRAM CHAUHAN): (a) The Storage and handling charges incurred by the FCI are allocated between the distribution cost which is a part of the Economic Cost and Buffer Carrying Cost as per the formula of distribution as approved by the Government. The details of the Storage and handling charges for the current year are as follows:

- (c) No, Sir. Open market prices vary from place to place and from time to time. While at certain centres the prices are lower than the PDS prices for non-BPL consumers, at other centres these are more than the same.
- (d) Government has already announced a National policy on Storage, Handling and Transportation of foodgrains which envisages private sector participation in storage and handling of foodgrains.
