ment to ensure that their land is not misused to foment trouble in India; if so, what has been the concrete response of the U.S.A. Government thereto?

THE MINISTER OF EXTERNAL AFFAIRS (SHRI I. K. GUJRAL): (a) Yes, Sir.

(b) The Government of India has expressed its deep concern to the US Government at Amanullah Khan's presence and activities on US soil in view of his known involvement in acts of terrorism directed against India. On 18 April the US Government revoked the visa of Amanullah Khan on grounds of Mr. Khan's support for terrorist acts. We have also requested the authorities for his detention.
