(c) whether the problem of pending industrial disputes was also discussed there at and if so, the steps proposed to be taken to solve the problem?

THE MINISTER OF LABOUR AND WELFARE (SHRI RAM VILAS PAS WAN): (a) to (c) The issues discussed in the Labour Secretaries' Conference and Labour Ministers' Conference held respectively on 19th and 20th April, 1990 were as follows: —

(i) Labour Participation in Management.

(ii) Review of Industrial Relations Legislation (covering proposed amendments to the I. D. Act and the T. U Act).

(iii) Review of developments relating to unorganised Labour.

(iv) Review of implementation of Labour Laws.

(v) Law<sub>s</sub> and policies relating to Child Labour, Women Labour and Emigrant Labour.

(vi) Issues pertaining  $t_0$  employment regulation and training.

## Lack of Fire fighting equipment in highrise building in Delhi

\*75. SHRI KRISHNA KUMAR BIRLA: Will the Minister of URBAN DEVELOPMENT be pleased to state:

(a) whether it is a fact that despite various fire incidents, top security buildings like Akashvani Bhawan, Sena Bhawan, Vayu Bhawan various hospitals and other sensitive buildings in Delhi continue to be without the minimum fire fighting equipment and are on the list of 'unsafe buildings';

(b) if so, what are the reasons for the delay in making these buildings self-sufficient in fire-fighting equipment to avoid major fires in these buildings; and

(c) what action has been taken by Government to fix the responsibility for the gross negligence and also to provide fire-fighting equipment in these buildings without  $an_y$  further delay?

THE MINISTER OF URBAN DEVE-LOPMENT (SHRI MURASOLI MARAN): (a) and (b) On a review of the requirements of the Delhi Fire Prevention and Fire Safety Act, 1986 brought into force in March, 1987, the Government sanctioned a number of fire safety work<sub>s</sub> in the high-rise buildings maintained by the Central Public Works Department, given in the Statement in order to bring them in conformity with the rules framed under the Act. A dedicated Project Team under a Superintending Engineer has been sanctioned in the CPWD in July, 1989 for execution of these fire safety works. These have already been started by the CPWD and the details are in the same Statement, (Columns (2) and (3). Akashavani Bhavan is not maintained by the CPWD and separate arrangements for maintenance of this building are made by the All India Radio themselves.
