therefore, relinguished by OIL. Further, 4451 line kms. of seismic surveys were also conducted in the North Eastern Coast Offshore area, off the Orissa coast. Four exploratory wells have been drilled. Although no commercially exploitable hydrocarbon reserves have been discovered evidences were obtained which warranted further seismic surveys. 2800 line kms. of 2-D surveys and 3300 line kms. of 3-D sudveys have been conducted during January to March, 1988. The results are being processed and interpreted. The future programme would depend upon the results of the interpretative work in hand.

Complaints against large private sector units setting up small scale industrial units
