(c) how far the controversy over safety aspect has affected the progress of the project?

THE MINISTER OF **ENERGY** WITH ADDITIONAL CHARGE OF THE MINISTRY OF CIVIL AVIA (SHRI ARIF MOHD. KHAN): (a) (c) In view of the apprehen to sions expressed in certain quarters about the safety of the dam structures, steeming from the location of the dam in a seismic area, it was considered advisable to carefully go into the mat ter once more to set the doubts at rest. Accordingly, a High Level Com mittee of Experts was constituted by the Government an 23rd March, 1990 to examine the issues relating to the safety aspects of the Tehri Dam Pro and examine whether all poten dangers arising out of the city of the area have been taken note of and all precautions taken in plan ning the project. After carefully going. into the matter and even after assu scenario, it ming the worst earthquake has been concluded by the High Level Committee of Experts that the Tehri Dam, as proposed and designed, would be safe; that all dangers arising out of seismicity have been taken note of and taken care of in the planning of the Tehri Dam Project; that the pres ence of the reservoir does not increase the size of an earthquake event, and therefor. no additional consideration fo'r reservoir induced seismicity necessary.

The conclusions and recommendations of the Committee would be duly taken into account in according investment approval to the revised estimates of the Tehri Project. The controversy on the safety and environmental aspects of the project has somewhat adversely affected the progress of the project and rehabilitation works.
