- (lb.) if so, whether Government have ever conducted any study on the effects of pollution from run-offs of irrigation water from agriculture lands; and

THE MINISTER OF STATE THE MINISTRY OF ENVIRONMENT AND FORESTS (SHRIMATI MANEKA GANDHI); (a) There is water pollution from the use of pesticides in agriculture.

(b) End (c) About 600 samples from the Ganga river have been tes ted during the last two years for the presence of fertilizers and pesticides. In the case of fertilizers that were tested for, the levels ere within per missible limits. In regard to pesticides, the analysis shows that the presence pesticides that were tested for, were usually above acceptable levels.

(b) and (c) The responsibility of setting up of wildlife sanctuaries vests with the State Government. The Wild life Institute of India, in its report "PLANNING A PROTECTED AREA NETWORK IN INDIA" has recomm ended that the present network of one national park and 17 wildlife san ctuaries in Andhra Pradesh should be expanded to include 6 national parks and 25 wildlife sanctuaries, thus incr easing the total area under the protec ted area network from 10174 sq. kms. to 13861 sq. kms. A copy of the Report has been sent to the State Govern ment of Andhra Pradesh for further necessary action.

There is no reservation for appointment to these posts as officers are brought on deputation from their parent Services
- The constitutional Sir. Yes. responsibility to safeguard the interests of Scheduled Castes and Scheduled Tribes developes equally in all officers of Government. The Members of the Screening Committee are Secretaries to Government of India and as such ere fully vested with the responsibility to ensure that the claims of the members of the Scheduled CaS» tes and Scheduled Tribes are taken into consideration consistent with the maintenance of efficiency administration in making recommendations as is prescribed under Article 335 of the Constitution. The Appointments Committee of the Cabinet is a Standing Committee of the Cabinet.
