## Inclusion of more Elective Subjects for Students of KVS at Plus Two Stage

\*115. SHRI ISH DUTT YADAV: SHRI ANAND PRAKASH GAUTAM;

Will the PRIME MINISTER be pleased to refer to answer to Unstarred Question 1785 given in the Rajya Sabha on the 27th March, 1990 and state:

- (a) whether a Committee was set-up under the Chairmanship of Shri Bhujang Rao to consider and report on the suggestion by All India Kendriya Vidyalaya Teacher<sub>s</sub> Association for inclusion of more elective subjects in KVS;
  - (b) if so, what are the details thereof;
- (c) what are the details of levels at which the suggestions of AIKVTA, was discussed and decided upon;
- (d) whether AIKVTA was invited ta elaborate their demand;
- (e) what are the detais of constraints of resources in introducing new and

more subjects at plus two stage in Kendriya Vidyalayas; and

(f) what financial constraints are there in introducing Drawing, Physical Education, Music, when teachers of these subjects are already there?

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE SHRI CHIMANBHAI DEVELOPMENT MEHTA): (a) to (f) The AU India Kendriya Vidyalaya Teachers' Association (AIKVTA), in its meeting with the Chairman, Kendriya Vidya-laya Sangathan, in November 1989 requested for introduction of new elective subjects such as Physical Education, Music, Drawing and Civics at plus 2 stage. After discussions it was decided by the Chairman of tha Sangathan that the issue might be examined further. Following up on this, Commissioner, Kendriya Vidyalaya Sangathan former a Committee of five numbers under the Chairmanship of Shri T. S. Bhujanga Rao, Deputy Commissioner (Academic), Kendriya Vidyalaya Sangathan in February, 1989. The Committee has submitted Its report in February, 1990.

Every demand is not invariably discussed with the concerned Association, in this case, no discussion was arranged with the AIKVTA by the Committee.

Kendriya Vidyalayas cater to educational needs of the children of transferable Central Government Employees including Defence Personnel. Hence, it is necessary to have uniformity in the courses throughout the country. Offering more elective subjects at plus 2 level uniformally in all Kendriya Vidyalayas would subs tantially increase the requirement of funds inter, alia, for additional teachers and class rooms. Keeping in view the resources contraints, the number of new elective subjects has had to ba kept restricted. However, the Kendriya Vidyalaya Sangathan will sxamine the matter further with reference to the report of the above Committee.
