THE DEPUTY MINISTER IN THE MINISTRY OF FINANCE (SHRI ANIL SHASTRI): (a) A

suggestion had been included in the papers prepared by ASSOCHAM for a Seminar on Fiscal Policy for Growth held on 13-04-1990 that 25% to 30% of the share capital of some of the Public Sector Undertakings be disinvested and the concept of offering stock option to employees be widened.

(b) As this was only one of the point included in a background document for a technical session of the Seminar, the question of a Government decision does not arise.

Central Assistance to States for Debt Relief

*137. SHRI RAJNI RANJAN SAHU : Will the Minister of FINANCE be pleased to state :

- (a) whether Government propose to provide assistance to State Governments for debt relief; and
- (b) if so, what are the details of the proposal ?

THE DEPUTY MINISTER IN THE MINISTRY OF FINANCE (SHRI ANIL SHASTRI): (a) and (b) The Central Government has decided that it will bear the full responsibility of debt relief in respect of loans taken from public sector banks and Regional Rural Banks in the Central Sector. So far as Cooperative Banks and land Development Banks in the State Sector are concerned, in order to assist the State Governments in regard to debt relief scheme on the Central pattern, the Central Government will bear 50 per cent of the burden of relief on loans taken from these banks in the State Sector.

Promotion of Tourism

- (a) whether Government have recently announced a package of incentives to promote tourism in the country;
 - (b) if so, what are the details thereof;
- (c) whether Government propose to identify a large number of tourist spots in the country having potential for adventure;
- (d) if so, what are the details thereof; and
- (e) what is the estimated expenditure to be incurred to boost tourism in the country during the next two years?

THE MINISTER OF STATE IN THE MINISTRY OF PARLIAMENTARY AFFAIRS AND THE MINISTER OF STATE IN THE MINISTER OF STATE IN THE MINISTRY OF TOURISM: (SHRI SATYA PAL MALIK): (a) and (b) The Government have decided that new approved hotels set-up in selected areas not having 300 rooms of reasonable standard (3-star and above) would be exempted from expenditure tax for a period of 10 years and also be given 50% exemption from tax under section 80(1) of the Income Tax Act. The places designated for this purpose are the following:

- (i) Hilly areas above 3000 feet
- (ii) Rural areas
- (iii) Pilgrim places
- (iv) Places identified and notified by the Ministry of Tourism in the travel circuits where tourism is
