Development and expansion of various airports in Madhya Pradesh

Will the Minister of CIVIL AVIATION be pleased to state:

(a) what is the amount likely TO bs . spent for the development, expansion and for providiig night landing facilities ai various aborts in Madhya Pradesh, during the <urent financial year; and

(b) by when all these airports are likely to be equipped with night landing facili ties?

THE MIMISTER OF ENERGY WITH ADDITIONAL CHARGE OF THE MI-NISTRY OF CIVIL AVIATION (SHRI ARIF MOHD KHAN). (a) The National Airpo-ts Authority plans to spen. i Rs. 50. 00 1) khs towards night landing facilities in the current financial year.

(b) The National Airports Authori-y has four air, K>rts viz. Bhopal, Khajuraho, Indore and fcatpur in Madhya Prades'J. These are ustid by jet aircraft. Night landing facilities have already been provider; at Bhopal, Khajuraho and Indore. At Raipur airport, the work of providing night landing facilities is expected *to* be completed by the end of July, 1990.

Alternative source of Energy in Tribal Areas

(a) whether Government have any plan to provide alternative source of energy in the tribal belt? of Central India so as to prevent destruction of forests, caused by use of firewood as domesic fuel; and

(b) if so, what are the details threof?

THE MINISTER OF ENERGY WITH ADDITIONAL CHARGE OF THE MI-NISTRY OF CIVIL AVIATION (SHRI ARIF MOHD. KHAN): (a) The Government has a broad-based plan to promote the use of alternative sources of energy throughout India, including ths tribal belts of Central India.

(b) The programmes in this regard incluede the promotion of Mogas plants, improved chulhas, solar cookers, and solar water heaters for providing alternative methods for cooking and heating, solar photovoltaics for providing lighting for various purposes, and energy plantations for meeting the fuel needs of the rural and tribal areas.

Long range marginal cost concept for fixing fair selling price

739. SHRI SATYA PRAKASH MALAVIYA: Will the Minister of PET-ROLEUM AND CHEMICALS be pleased to state.

(a) whether it is a fact that report on aromatics by BICP in 1990 has recommended adoption of Long Range Marginal Cost concept for normative price of all aromatics;

(b) whether the above¹ referred report of BICP on aromatics is being taken as the basis by Government for fixing the fair selling price of aromatics;

(c) whether Government have decided as a matter of policy to use LRMC for fixing fair selling prices for all petrochemical products; and

(d) whether this concept will also be extended to paper, fertilizers and aluminium?

THE MINISTER OF PETROLEUM AND CHEMICALS (Shri M. S. GURUPADASWAMY): (a) BICP in its Aromatic Report has included Long Ruange Marginal Cost (LRMC) concept as one vt the tools of price analysis.

(b) Theire is no price control over Aromatic products. Fair selling price! worked out by BICP is only used as bench mark for calibration of appropriate tariff levels for imports.
