DR BAPU KALDATE:

Will the Minister of ENERGY be pleased to state:

- (a) whether the Chukha Hydel Project. a joint venture of India and Royal Government of Bhutan, has been completed;
- (b) whether any workers from India were recruited for this project;
- (c) whether these workers have been declared surplus and rendered unemployed; and
- (d) if so, what steps are being taken by Government to provide employment to these workers?

THE MINISTER OF ENERGY WITH ADDITIONAL CHARGE OF THE MINISTRY OF CIVIL AVIATION (SHRI ARIF MOHD, KHAN): (a) The Chukha Hydel Project in Bhutan, which

is a project of the Royal Government of

Bhutan being executed with Indian financial and technical assistance, had been commissioned in October, 1988. There some related works, like transmission lines, which are nearing completion.

- (b) Yes, Sir
- (c) and (d) On completion of the major works of the project, some of the workers have been declated surplus. The Project Authorities have approached various Organisations, including those of the Government of India, for exploring possibilities of absorption of these surplus workers, and as a result, some of these workers have already been provided alternative employment

Prices of Cement in Eastern States

- 695. SHRIMATI KAMLA SINHA: Will the Minister of INDUSTRY be pleased to state:
- (a) whether Government's attention has been drawn to news-item published in 'Business Standard' of the 29th April, 1990 captioned 'Cement price freeze till end of May';

- (b) if so, whether it is a fact that exfactory rate per bag of cement (inclusive of all taxes) in the Eastern States, including Bihar was Rs. 62/- during the last week of February, 1990;
- (c) whether it has thereafter gone up to more than Rs. 105/- per bag; and
- (d) if so, what steps Government are taking to hold the price of cement?

THE MINISTER OF INDUSTRY (SHRI AJIT SINGH): (a) Yes, Sir.

(b) As per the reports received, the price per bag had ranged from about Rs. 70/- to Rs. 95/- in the Eastern region in the last week of February, 1990. A statement showing the retail price of cement per bag, including all taxes, in the Eastern region from 19th February, 1990 to 28th February, 1990, is attached. (See below).

- (c) In some areas in the Eastern region, the prices had gone up to Rs. 105 per bag during April, 1990.
- (d) Following are among the important steps taken by the Government to hold the prices of cement:—
 - (i) Major Cecent Producers have agreed to roll back their ex-stockists prices to the level of 31st March, 1990.
 - (ii) State Government/Union Territories have been advised to ensure that the prices of cement are maintained at the level not above those of 31st March, 1990 and that the dealers do not indulge in profiteering at the retail level.
 - (iii) Railway Board has issued instructions to move cement on an emergent basis on designated routes.
 - (iv) The movement of price and availability of wagons for cement transportation are being closely monitored.
