THE MINISTER OF STATE IN THE MINISTRY OF SCIENCE AND TECHNOLOGY (PROF. M. G. K. MENON): (a) and (b) Government has seen the report.

(c) and (d) Scientists individually and in groups do bring to the notice of the Government their perception of the problems that they face. Government has ongoing, mechanisms to review issues raised by them and to take corrective measures, whenever required. In the case of a recent memorandum received from the National Committee of Young Scientist's and Research Fellows, a high level group under the Chairmanship of Prof. Yash Pal, has been set up to look into the points made.

- (c) The following changes, broadly, were made in transfer guidelines during the year 1989-90:
  - Addition of 'Compelling administrative and compassionate Reasons' as a ground for transfer as against the earlier criterion of 'Administrative Reasons'.
  - (2) The earlier medical ground for transfer was Specific. This has been broadened and made general.
  - (3) Earlier, death in the family of-the teacher was mentioned as a specific ground for transfer. This specific mention has been dispensed with.
  - (4) Earlier, transfer of unmarried girls to places of their convenience was not provided for. Now it has been provided.
  - (5) Provision has also been made for transfer on grounds of teachers developing physical handicaps in the course of employment in KVS.
- (6) For Principals, previously there was a fixed tenure-5 years in a station. Now this has been dispensed with.
- (7) Post Graduate Teachers and above will be posted on promotion/direct recruitment to another stats instead of another language area or region, as laid down earlier.
- (8) Post Graduate Teachers/Vice-Principals/Principals and above will not be posted on promo tion/direct recruitment out if their home state already working there, if they have less then 3 to retire years Of 5 years, laid down earlier. subject to availability of vacan cies.
