Allotment for Border Area Development Scheme in Gujarat

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RES-OURCE DEVELOPMENT (SHRI CH-IMANBHAI MEHTA): (a) During 1986-87 of the Seventh Plan, the Border Area Development Programme was implemented by the Ministry of Home Affairs, who released a grant of Rs. 11 crores to the Government of Gujarat for development of infrastructure around border areas. From 1987-88 onwards, implementation the programme was transferred the Ministry of Human Rosource Development, Department of Education, who released a grant of Rs. 17.27 crores to the State Government during the remaining 3 years of the Seventh Plan period for educational development in Kutch and Banaskantha districts.

Rehabilitation of Ex-servicemen by Ordnance Factories in the country

- (a) whether the Ordnance Factories in different parts of the country have not provided proper rehabilitation to the ex-servicemen:
- (b) whether the ex-servicemen who joined the Ordnance Factories about a decade ago as Supervisors are continuing in the same post without any promotion;
 - (c) if so, the details thereof;
- (d) the number of such persons working in Ordnance Factories Kanpur and Jabalpur; and
- (e) what further steps are proposed to be taken to promote them with retrospective effect in order to ensure their proper rehabilitation?

THE MINISTER OF STATE IN THE MINISTRY OF DEFENCE (DR. RAJA RAMANNA): (a) No, Sir. Ordnance Factories have properly lowed Government orders regarding reemployment of Ex-Servicemen for their rehabilitation.

- (b) and (c) Yes, Sir. There are five such Supervisors, who belong to the Technical trade.
 - (d) One and three, respectively.
- (e) The general orders relating to re-employment of ex-servicemen not provide for any weightage military service towards seniority for the purpose of promotion.
