

Complaints and Grievances of the Telephone Subscribers of Bulandshahr Town

921. SHRI SANGH PRIYA GAUTAM: Will the Minister of COMMUNICATIONS be pleased to state:

(a) whether it is a fact that after going into the complaints and grievances of the telephone subscribers of Bulandshahr town, Government decided to install an electronic exchange at Bulandshahr;

(b) whether it is also a fact that no electronic exchange has been installed so far at Bulandshahr; if so, what are the reasons therefor; and

(c) whether Government propose to install the electronic exchange at Bulandshahr in the current year, if not, what are the reasons therefor?

THE MINISTER OF STATE (INDEPENDENT CHARGE) IN THE MINISTRY OF COMMUNICATIONS (SHRI JANESHWAR MISHRA): (a) Government has decided to install an electronic exchange at Bulandshahr as per normal expansion programme.

(b) Yes, Sir. On account of shortage of electronic exchange equipment, these exchanges can be installed in a phased manner only.

(c) Due to paucity and non-availability of the equipment electronic exchange is not likely to be installed at Bulandshahr during current year. However based on the demands a 2K Remote Line Unit to be connected to Ghaziabad E10B exchange has been proposed for allotment during the 8th Plan.

Fresh Guidelines to States for tackling Communal Riots

(a) whether Government have recently issued fresh guidelines to the State Governments on tackling riots;

(b) if so, the details thereof;

(d) if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI SUBODH KANT SAHAY): (a) to (d) Yes, Sir. The Central Government has issued guidelines to States/UTs for promotion of communal harmony. These include, among other things, posting of impartial officers with known integrity, strengthening of intelligence gathering system, setting up of special courts for expeditious trial of communal riot cases, role of media and the Police, etc.
