(d) Since no lighting arrangements grills and swings have been provided in the parks, the question of their rectification/replacement does not arise.

Construction of bus stop in Hari Nagar

- 1140. SHRI JAGAD1SH JANI : Will the Minister of URBAN DEVELOP-MENT be pleased to refer to reply to Unstarred Question 2253 given in Rajya Sabha on 30th March, 1990 and state :
- (a) when the said layout plan for the area was prepared; and
- (b) whither Government propose to change the Master Plan for the benefit of the health of the people and chalk out a plan which may accommodate a piece of land for a Mini Bus Stop so that the plants and green land is saved in an other wise pollution infested area?
- THE MINISTER OF URBAN DE-VELOPMENT (SHRI MURASOL1 MA-RAN) : (a) The plan ol the area was prepared by the Delhi Development Authority during 1986.
- (b) The proposed Mini Bus Station in Hari Nagar area is a public lacility for the convenience of the general public and there is no proposal to change the land . use of this site.

Norms for distribution of Phosphoric Acid

- 1141. SHRI ASHOKNATH VERMA: Will the Minister of AGRICULTURE be pleased to refer to the reply to Unstarred Question 556 given in the Rajya Sabha on the 16th March, 1990 and state:
- (a) what are the norms laid down by Government lor distribution of Phosphoric Acid and Ammonia ; and
- (b) whether Phosphoric Acid would be imported in crystal form or in liquid form with grades/percentages *I*
- THE DEPUTY PRIME MINISTER AND THE MINISTER OF AGRICULTURE (SHRI DEVI LAL) : (a) No norms have been laid down by the Government so far for the distribution of phosphoric acid and ammonia by the canalising agency (MMTC) to the. user companies. However, phosphoric acid is being allso cated by MMTC to various users in consultation with the Department of Fertilizers on the basis of licensed capacity, past allocation and the quantity authorised for import.
- (b) Phosphoric acid is imported in liquid form (generally referred to as

Merchant Grade Acid or MGA) with P 205 content ranging from 52% to 54%.

- THE MINISTER OF STATE IN THE DEPARTMENT OF AGRICULTURE AND COOPERATION IN THE MINISTRY OF AGRICULTURE (SHRI N1T1SH KUMAR) : (a) Mother Dairy installs Insulated Containers keeping in view availability of milk from other sources in the area, marketing

potential, conwiucsal viability, capacity to meet milk requirement from a new outlet suitability of the premises where the container is to be ins»alled, availability of wide and proper approach road for plying of heavy duly milk tankers the Dairy and traffic conditions hygienic condition of the place and its surroundings where the container is to be installed etc.

A Committee of officers examines any request/proposal for installation of an Insulated Container with relerence to the criteria menteoned and gives its recominerdations. Based on the recommendations a decision is taken about the installation of a container.
