Manufacture of photosensitised materials by Hindustan Photo Films Manufacturing Company

Will the Minister of INDUSTRY be pleased to state:

(a) whether it is a fact that (Hindustan Photo Films was set up some 30 years back for the manufacture of 'photosensitized materials from Base materials, yet their activities to the extent of 60 percent are still concentrated towards the Slitting and Confectioning from imported jumbo rolls; and

(b) if so, what corrective steps Government propose to take in this regard?

THE MINISTER OF INDUSTRY (SHRI AJIT SINGH): (a) and (b) M/s. Hindustan Photo Films Ltd., (HPF) was set up in 1960 for manufacture of a range of Black and White products and Medical X-ray films (CTA). To meet the increasing demand for colour products HPF has undertaken conversion of these products from imported jumbo rolls. It is also setting up integrated facilities for manufacture of polyester based medical X-ray, Industrial X-ray and Graphic Art films. This project is scheduled to be completed by October, 1991.

(क) क्या राष्ट्रीय परिवार कल्याण प्रशिक्षण कार्यक्रम के लिए विश्व बैंक से 85 करोड़ रुपये की अनुदान सहायता राशि प्राप्त हुई है ;

(ख) इसमें से कितनी राशि प्रशासनिक अकादमी संस्थान, भोपाल के अंतर्गत

परिवार कल्याण का एक शीर्ष-केन्द्र के निर्माण पर खर्च की गई है ;

(ग) क्या इस प्रकार का व्यय विश्व बैंक द्वारा दी गई अनुदान सहायता राशि के उद्देश्य को पूरा करता है; और

स्वास्थ्य एवं परिवार कल्याण मंत्रालय में राज्य मंत्री (श्री रशीद मसूद) : (क) भारत सरकार और विश्व बैंक के मध्य हुए करार के अन्तर्गत यह बैंक मध्य प्रदेश, उत्तर प्रदेश और आन्ध्र प्रदेश में राष्ट्रीय परिवार कल्याण प्रशिक्षण और जनशक्ति विकास जनसंख्या परियोजना के कार्यान्वयन के लिए भारत सरकार को ऋण देगा। भारत सरकार ने मध्य-प्रदेश में इस परियोजना के 42.57 करोड़ रुपये शेयर सहित 199.77 करोड़ रु. की कुल लागत से यह परियोजना अनुमोदित की है।

(ख), (ग) और (घ) इस परियोजना के अन्तर्गत, इन तीनों राज्यों में से प्रत्येक, में स्वास्थ्य और परिवार कल्याण के लिए एक शीर्षस्थ प्रशिक्षण संस्थान स्थापित करना है और मध्य प्रदेश के संबंध में उक्त संस्थान मौजूदा परिवार कल्याण प्रशिक्षण केन्द्र का दर्जा बढ़ाकर ज्वालियर में स्थापित करने का प्रस्ताव है। इस बात को ध्यान में रखते हुए, भोपाल में प्रशासनिक अकादमी के अन्तर्गत कोई शीर्षस्थ परिवार कल्याण केन्द्र स्थापित करने का प्रश्न नहीं उठता। शीर्ष प्रशिक्षण केन्द्र के निर्माण सहित इस परियोजना के अन्तर्गत राज्य सरकार को भारत सरकार द्वारा अभी तक कोई भी सहायता अनुदान नहीं दिया गया है।
