The decrease in percentage materialisation during Jan.—March, 1990 and April '90 is mainly on account of substantial increase in linkage of coal during this period.

Coal supplies made by CIL to Gujarat for other sectors in the last two quarters of 1989-90 and during the corresponding periods of the previous year are given in Statement I. [See Appendix CLIV, Annexure No. 60] Supplies made (by rail only) during April '90 and April '89 are also given in the Statement II. [See Appendix CLIV, Annexure No. 60.]

(b) and (c) On 12-5-1990, a message was received from the Government Gujarat regarding short supply of coal to textile and ceramic industries and coke to foundry units of Guiarat and requesting for 7 rakes of coal. CIL has been asked to step up coal despatches for industrial consumers of Gujarat. Since 12-5-1990, 7 rakes from SECL and 2 rakes from WCL have been despatched for textile, ceramic, pottery and other non-core sector consumers of Gujarat as per the following details:—
