KHAN): (al) to (c) There are two proposals; (i) to set up Rokhia Gas-based Power Project, Stage-*M* (10x8 MW) and (ii) Tripura Gas-based Power Project (500 MW) of the National Thermal Power Corporation, in Tripura. While the Feasibility Report for Tripura Gas Based Power Project by NTPC (500 MW) fe likely to be available by July, 1990; the other proposal regarding Rokhia could be considered for techno-economic clearance by CEA after alj the Inputs & clearances are tied up.
