

THE MINISTER OF ENERGY WITH ADDITIONAL CHARGE OF THE MINISTRY OF CIVIL AVIATION (SHRI ARIF MOHD. KHAN): (a) and (b) Taking note of alleged irregularities in the purchase of A-320 aircraft, the CBI has registered an FIR on the 29th March 1990. The matter is under investigation.

**Vacant posts of pharmacists and store keepers in CGHS units of Indian systems of medicine and homoeopathy**

1199. SHRI JAGDISH JANI: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

(a) whether Government are aware that in the various CGHS units of Indian systems of Medicine and Homoeopathy in Delhi/New Delhi the duty of registration work and distribution of medicines is performed by Group 'D' employee due to the non-posting of pharmacists or store keeper there; and

(b) if so, what effective steps Government propose to take to fill up the vacancies of pharmacists and store keepers in the units referred to above?

THE MINISTER OF STATE OF THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRI RASHEED MASOOD): (a) The Services of Group 'D' employees are utilised for registration of beneficiaries in absence of store-keeper-cum-pharmacist under the supervision of physicians of the respective systems. However, the medicines are dispensed by the physicians with the assistance of the pharmacist. If the pharmacist is on leave then assistance of a Group 'D' staff is taken.

(b) A proposal for augmentation of staff in ISM units is under consideration.

**Vacant posts of homoeopathic doctors and pharmacists in CGHS**

1200. SHRI JAGDISH JANI: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

(a) whether it is a fact that a large number of posts of Homoeopathic doctors and pharmacists have been lying vacant at different homoeopathic CGHS dispensaries and store depots in the country;

(b) if so, what is the position as on the 30th April, 1990 in this regard; and

(c) the steps taken to fill up the vacancies?

**Overstay of staff in CGHS**

(b) whether it is a fact that the Medical/Para medical employees working at present in various CGHS dispensaries/units/hospitals/stores depots Zonal Head Quarters are continuing at the same place or the same post even after the completion of their normal tenure of stay;

(c) if so, what are reasons therefor;

(d) whether the overstay of doctors and staff is resulting in their indifferent attitude towards the CGHS beneficiaries; and

(e) if so, what steps are being taken in this regard?
